## **Exploring a Forgery Multiple**




Figure 2. The three multiples fit together!

I found these three forgery multiple errors in three different places, filed by subject. See **Figure 1.** Some forgery multiples are very rare so these called to me for a more thorough investigation and study. The first thing I noticed was the crease on all three strips. Being a puzzle aficionado, I turned them around and moved them to re-assemble the multiple. See **Figure 2.** These three strips were once a pane of at least nine! They are black on green glazed on creamy paper. I went to my Lyons Identifier<sup>1</sup> and quickly determined that these are as follows:

Boyce's City Express Post	Forgery C
Kidder's City Express Post	Forgery D
Messenkope's Union Square Post Office	Forgery C

I also noted that Hussey is not among the identified forgers for any of these three local posts. Odd. I believe he was the most prolific of the early forgers, and this certainly looks to me like his work.

Next I turned my attention to the Thomas Wood's printing record. Thomas Wood was the main printer of genuine Hussey stamps and many of his forgeries. He recorded making the forgeries in 1862-1866. He also recorded the quantity he printed and they were assigned Wood recording numbers.

Only the Kidder's forgery is recorded in the Wood's records. It is #85 and he printed 2000 stamps. The manuscript entry appears to be Feb 27, 1865 and September 18, 1865, printing charge \$3.50. The image appears to be the reprint which was printed in a pane of 10. See Figure 3.

The reprint and Forgery D of the Kidder's stamp have similarities in the lettering and the octagonal design elements but the horse and rider have differences. I note the Forgery D Kidder's forgery printed in the following colors:

Black on green glazed surface paper Black on vermilion glazed surface paper

I confirm that both of these printings are on creamy paper.

In the April 2002 issue of *The Penny Post*<sup>2</sup> I explained other Hussey products not found in the Wood notebook but found sold by Hussey in his December 1863 price list. 69 products were listed by Hussey in his price lot and only 35 of these appeared in the Wood's notebook. I concluded Hussey had a second printer. I went on to identify many forgeries that I believe were made for Hussey based on his price lists.

Boyce, Kidder's and Messenkope's were not among the many products I believed Hussey made when I reviewed his price list in 2002.

#### **Hussey's Multiples of Forgeries**

When I think of forgeries made in multiples Hussey is the likely forger. No multiples of Taylor forgeries exist. I own one multiple made by Scott and it is unique and it is not a local post. I would challenge the readers to produce a Scott forgery multiple. Hussey on the other hand was prolific in producing forgeries in multiples. Here are a few examples:

And of course the infamous sheet of Broadway Post Office Forgery E and the American Letter Mail Forgery A in 10 alternating rows of 5. See Figure 4.

Quite a list which includes most known multiples all emanating from the same forger.

Many more come to mind and I would suspect some of the reprint sheets were produced for Hussey, but that is for a future study.

#### Variations of the Multiple in Question

**Figure 5** shows three examples of Boyce's Forgery C made by or for Hussey. The different shades suggest multiple printings. These are not rarities and are not scarce suggesting a good quantity was printed.

#### **Identifying Hussey Products**

Here is my methodology that I established in 2002.<sup>3</sup>

In order to identify the forgery or reprint attributable to Hussey one must examine the stamps looking for the following traits:

- 1. Multiple position or clichés to match Hussey's style.
- 2. Papers and ink colors matching known Hussey products.
- 3. Styles matching known Hussey products.
- 4. Quantities of stamps matching other Hussey products.
- 5. Deductive reasoning.
- 6. Reference to advertisements.
- 7. Process of elimination.

Some of the Hussey forgeries are very easy to identify and others are more elusive. Some of these items I will examine more closely and show a pattern of repeat printing on different papers. This was necessary as items sold and more had to be printed to fill orders. Hence the shade differences shown in **Figure 5**. Further investigation and study will yield more results. On page 15 of my Part I article on Hussey<sup>4</sup> I identified the following Hussey products on green glazed surface colored paper on creamy paper:




Figure 7. Three different shades of The American Express Company Forgery A representing the three different printings of this stamp. The American Express Company Forgery A is identified by Thomas Wood as recorded in **Figure 6** indicating three printings. **Figure 7** shows two multiple and a single of the American Express Company Forgery A in three different colors from the three printings. This is similar to the Boyce's shade variations shown in **Figure 5**.

#### **Another Multiple Discovery**

I next went to see what I could find out on Price's 119L2, Forgery A and I found a photo of the multiple shown in **Figure 8.** I quickly identified the forgeries in the strip as follows:

Smith's City Express Post	Forgery B
Messenkope's Union Square Post Office	Forgery C
Boyce's City Express Post	Forgery C
Price's City Express Post	Forgery B

#### A Look at Smith's City Express Post Forgeries

There are only three forgeries of the Smith's City Express Post with a border similar to the original stamp. Forgery D has a differently designed border. Forgeries A, B and C are Patton types III, IV and IX. Forgery C has an extra rectangular border and has previously been identified as a Moens forgery. That leaves only forgery types A & B as possible Hussey candidates. I have the multiple of Forgery B shown in **Figure 9.** I also see three shade varieties of Forgery B. I am leaning heavily toward concluding that Smith's City Express Post Forgery B is a Hussey product.

#### **Deductive Reasoning**

The multiple shown in **Figure 8** would all be Hussey forgeries and would match the multiple shown in **Figure 2** in that they both contain Boyce's City Express Post Forgery C and Messenkope's Union Square Post Office Forgery C. The American Express Company Forgery A is a previously known Hussey product and is printed in the same shades as the Boyce's City Express Post Forgery C. The American Express Company Forgery A is also known in multiples showing the uniquely different printing shades of Hussey products.

#### The J. Walter Scott Forgeries

I can eliminate J. Walter Scott as a possible forger of these stamps simply by knowing that Scott is known to have only made one forgery of each known local post and the Scott forgeries of these local posts have been identified as follows:

Boyce's City Express Post	Forgery A
Kidder's City Express Post	Forgery B
Messenkope's Union Square Post Office	Forgery B
Price's City Express Post	Forgery D

#### Testing

Using the X-ray spectrometer I tested the ink and paper of the American Express Company Forgery A, the Smith's City Express Post Forgery B, Messenkope's Forgery C and Boyce's City Express Post Forgery C and found them to be of the same paper and ink. Since the American Express Company Forgery A is a known Hussey product they could all be confirmed as Hussey products. It is also true that this paper and ink was available in New York City during this time period.

#### **Quantities of Forgeries**

Boyce's Forgery C, Kidder's Forgery D, Messenkope's Forgery C, Price's Forgery B and Smith's Forgery B are all known in quantity reflecting the fact that they were all printed in multiples.


#### Summary

In my 2002 extensive study I presented more than 80 reprints and forgeries that I believe could have been made by Hussey. This was based on pricelist advertisements by Edward Moore & Co. who sold Hussey products. I now suggest adding five more subjects to that list based on the presentation of this article. I believe the following were produced for Hussey:

Boyce's City Express Post	Forgery C
Kidder's City Express Post	Forgery D
Messenkope's Union Square Post Office	Forgery C
Price's City Express Post	Forgery B
Smith's City Express Post	Forgery B

There is more work to be done concerning Hussey products. Please drop me a line and an image of other forgery multiples that you might have for further study. It is a fertile subject.

### The Case for a Space Filler

In my efforts to plate all 50 positions of the United States City Despatch Post, I acquire any examples I can. Even the roughest of stamps can be useful in a color study or to confirm plating marks. I focus mostly on Scott# 6LB5 and its many shades. As I work through the positions I come across stamps that I cannot plate. Either the example is too damaged or the literature is too vague. I will sequester scans of these into a "mystery folder" and then group them when I find similar markings. Once I have two or three examples of stamps that are from the same position, there is usually enough information within the group to deduce the position.

In the case at hand, I had acquired the roughest of these examples for a tuppence and mounted it with the same respect I give any of these stamps. See **Figure 1**. (For clarity, I will call this stamp #1.) At a later time, I acquired the example on piece. See **Figure 2**. (Call it stamp #2.) It had a very interesting "spur" on the 'N' of 'UNITED.' See **Figure 2a**. I thought for sure such a distinctive marking would be in the literature but, alas, I couldn't find anything matching that description in the Calvet Hahn plating notes<sup>1</sup> and finally had to set it aside.

And then recently, I acquired a second stamp with that same spur on the 'N' of 'UNITED'! See **Figure 3** and **Figure 3a**. (Call it stamp #3.) And I thought great! More information about that position and perhaps now I could plate it. I went through my usual ritual and process of elimination and still wasn't sure of the position.

#### A Little Background

My introduction to the United States City Despatch Post (USCDP) stamp was when I read an article by Mark Scheuer in the United States Philatelic Classics Society's journal, "The Chronicle," about the census that the society had posted on their website.<sup>2</sup> The stamp had a rustic and primitive charm that I found irresistible.

The article pointed the way to many important references on both the City Despatch Post and the USCDP. As I began to study this issue I learned that the USCDP stamps were replacements for the original local stamps produced for the City Despatch Post started by Alexander Greig in February of 1842. The New York City Post Office (NYC P.O.) acquired Greig's operation in August of 1842 to have its own dispatch service to compete with all of the local carrier services that delivered mail locally and to and from the post office. These stamps were the first self-adhesive stamps to be issued by authority of the U.S. government. (For more information on the history of the City Despatch Post and the interesting evolution of the "Greig Plate" see Scott Trepel's monograph, "The City Despatch Post 1842-1852 Issues" published by Robert A. Siegel Galleries in 2003.)

A new design and printing plate were produced for the USCDP stamps. The USCDP stamps were produced in sheets of two panes of 25 subjects with each pane being five columns across by five rows. The position designations are given as a number for the position in the pane starting with the upper left corner and then an "L" or "R" for left or right pane, respectively. For example, the upper left position is "1L" and the stamp below it would be "6L." This is in contrast to the "Greig Plate" which has 42 subjects with six columns of seven entries.

This plate must have been made in haste because the NYC P.O. acquired the operation August 1, 1842 and started service by August 16, 1842 which only allowed a couple of weeks to produce the stamps. The City Despatch Post and United States City Despatch Post stamps can sometimes be confused for one another. I find the easiest way to distinguish which issue I'm looking at is that the USCDP stamps have a "bug" (as Hahn calls them) on each side between the "UNITED" and "THREE" on the left and between the "POST" and "CENTS" on the right. Also, Washington's portrait is more elongated and there is more distance between the top of his head the upper oval frame. And, of course, the USCDP stamps have "UNITED STATES CITY DESPATCH POST" running up and over Washington's portrait. The two stamps can by seen side by side in **Figure 4**.

The Scott catalog designates the stamps from the "Greig Plate" as 40L1-8 and 6LB1. The Scott numbers for the USCDP plate are 6LB2-7. The 6LB1 stamps were the remainders of the first Grieg issue that were honored by the NYC P.O. (at least until they issued their own stamps). 6LB1 is the 40L1 stamp with either a "US in octagon" cancel, a USCDP cancel, or NY town cancel. These are quite rare. As the Scott catalog states:

"Used examples that do not bear the official cancellation of the New York Post Office and unused examples are classed as Local stamps. See No. 40L1.

Some examples are canceled by a circular date stamp reading 'U.S. CITY DESPATCH POST' or, infrequently, a New York town postmark. When canceled 'FREE' in frame they were used as local stamps. See 40L1 in Locals section.

No. 6LB3 was the first stamp issued by authority of the U.S.P.O. Department."<sup>3</sup>




Figure 5a. Detail of doubled dividing line at top, vertical ghost laydown line from the top of head to 'I' of 'CITY', and weak left frame line of Stamp #3.

Even though I didn't have any position dot data which can be helpful in plating, I did have the "mark in the 'U'" as a quality clue. See **Figure 7**. I went through all the positions with irregularities in the 'U' of 'UNITED' (Positions 3, 8, 11, 12, 19, and 21R and 2, 4, 10, 14, and 17L) and cross the positions off the list that had qualities that would eliminate them from the running. Finally, position 4L was looking like a likely suspect.

The Hahn entry for position 4L states in full:

Position 4L -- The left position dot is to the right of the dividing line, while the right dot touches its line on the right side. There are dots at the upper ends of both right and left dividing lines, just above the top line. The *top dividing line is doubled almost its entire length*. There is a *short vertical scratch outside the left frame between the 'U' and the 'bug'. There is a mark in the 'U' of 'UNITED'*<sup>4</sup>




Figure 8. Matching marks in the left margin and frame between 'U' of 'UNITED' and the bug. Lower arrows pointing to matching scratches near the disrupted frame line.




Figure 9. Close up view of disrupted frame line in, from left to right, Stamps #1, #2, and #3. The scratch through the "bug" pointed out in Stamp #2 is common to every position and, therefore, was present in the original die.

There IS a very faint vertical scratch outside of the left frame as well as other matching scratches including one inside the frame by 'UNITED.' These are best seen in the example on piece (Stamp #2). See **Figure 8** and **Figure 9**. There is also a doubling of the top dividing line though if it is the "entire length" it is very faint towards the right as seen in **Figure 5**.




Figure 10. Close up of the marks around 'UNITED' in stamps #1, #2, and #3 from left to right. Note that Stamp #1 does NOT show the spur or the other marks to the right of 'UNITED'. The mark at the bottom of the 'U' is from a double transfer found in this position. The notch in the left upright of the 'U' is seen in every position and, therefore, was present in the original die.

A high resolution scan is worth a thousand words! I scan these stamps at 3200 dpi and bring them into an image editor and align the scans and then create a "comparator" to flip between images to check for matching marks. This "virtual comparator" can show a myriad of matching marks. As I looked closer I noticed that the 'N' spur stamps also shared other specks and dashes. Namely, two dashes under the 'T' and a small dot under the 'I' that matched exactly. See **Figure 10**. Also the ghost lay down line above Washington's head had a dot to the right of the line. The rough example had the exact same faint laydown line running from between the 'I' and 'T' of 'CITY' down to Washington's head however the dot was not present. See **Figure 6**. But everything else seemed to match. Then it dawned on me that I was looking at a "discovery" copy in that little rough stamp. This must have been an earlier state of the plate, that is, an earlier condition before these extra dings occurred.

Perhaps a tool was dropped on the plate after a lunchtime tankard of ale. Or an inking brush fumbled onto the plate as the printer rushed to fill another order for stamps. Regardless, something damaged the plate between the printings of these stamps.

The mark at the bottom of the 'U' of 'UNITED' is associated with a double transfer at this position. There is also some doubling of the broad shading lines of the left lapel in this position. The left lapel often shows faint doubling of the shade lines where the original entry was not completely erased. These new markings do not seem to be associated with the re-entry of the die at this position but rather damage that occurred after the early production had begun.

The cancel on Stamp #1 shows the double octagon cancel which is seen in the early days of the United States City Despatch Post before the cancelers started showing wear and leaving a single broader octagonal line. Stamp #1 also has a greener hue which leads me to believe this is from an earlier printing than the other two stamps. Stamps #2 and #3 are of such a similar color that they are probably from

the same printing. (Actually the colors are all so close to each other that they may be from the same printing batch.)

Plate marks can be variable as some marks fade away and new ones appear as the plate was used and this seems to be an example of that in the US City Despatch Post plate. And it may be that whatever caused these marks effected neighboring

positions. There are a number of marks I have seen in other positions that look like something was dropped on the plate. The intersection of positions 12L, 13L, 17L, and 18L shows a cluster of dots that shows this, which can be partially seen in the famous unused block of 12.<sup>5</sup> Figure 11 shows a scan of position 17L where one can see the scattershot collection of dots in the upper right corner.

#### In Conclusion

Thus concludes my case for acquiring even the roughest of stamps for you never know what they may contribute to filling in gaps in the story. Plating stamps can be challenging when the "fly specks" are variable but not insurmountable and can lead to exciting discoveries. One wonders what this stamp went through to end up in such bad condition and yet still it survives to tell its story. Now for the hunt for a clean example of position 4L in its early state!



## BLOOD'S 15L18: Part 18

On June 30, 1845 D.O. Blood & Co. acquired the Philadelphia Despatch Post and world's first pictorial stamps. On the next day the federal government eliminated private inter-city mail, although conceded to keep inter-city rates at recent competitive market levels. During the next few years three varieties of historic "striding messenger" stamps were produced,<sup>1</sup> were soon reserved for *local door delivery* "city stamps," and is today's logo for the Carriers and Locals Society.

By January 1846, double circle "post office stamps" "For the POST OFFICE," the world's first special purpose stamp<sup>2</sup> were produced in a shift toward two types of service: local delivery and outbound letters easily transported across the street to the post office with savings kindly passed on to the public.

Beginning in 1848 "BLOOD'S DESPATCH" appeared on the next five stamps. The company moved a few blocks west to Sixth Street,<sup>3</sup> across from Independence Hall. Single service price was reduced from 3 cents in May 1848, to 2 cents in July 1848, and 1 cent on January 8, 1849. Blood's volume discounts and bifurcated service were no longer necessary.

By March 1849 Philadelphia carriers were forced down to 1 cent for <u>all</u> services. No other city including New York ever matched such uniform low market levels, half of the prevailing 2 cents in the other cities. Blood's required prepayment, and did not allow collect service.<sup>4</sup> Once "collect" was reinstated three years later, however, it was doubled to 2 cents.

By 1852 **"BLOOD'S PENNY POST"** stamps appeared,<sup>5</sup> followed 2 years later with workhorse Bronze on Lilac 15L14.<sup>6</sup>

Over 20 years this very important private post produced 18 different stamps. This article analyzes the final stamp. The eighteenth and final article completes the entire series of all Blood's stamps.

#### 15L18




Figure 1. Single 15L18.

A new portrait stamp first appeared in May 1858. A single measures 25.7 mm high by 20.5 mm wide, and is listed in Scott Catalog as 15L18 "*l cent black*, *1855*,"<sup>7</sup> but <u>incorrect</u> by several years. Figure 1 includes a small portion of four adjacent stamps.




Figure 3. Block of 24.

In 1888 Charles Henry Coster referenced Henry Clay on reticulated *oval* disc inscribed "BLOODS PENNY POST" above, and "KOCHERSPERGER & C<sup>o</sup> PHILAD<sup>A</sup>" below, printed from steel plates in sheets of one hundred.<sup>s</sup>

Henry Clay's 1848 photograph, **Figure 2**, indeed bears striking resemblance to **Figure 1**. Born in Virginia 1777, Clay's Kentucky political career was extensive: Speaker of the House 1811-1813; lead Missouri Compromise of 1820; Secretary of State 1825 to 1829; US Senate 1831 to 1842 and 1849 to 1852; key role in the Compromise of 1850; died 1852.

The largest known block of 24 is shown in **Figure 3**. 15L18 is the only Blood's stamp known with trial color proofs and essays.




