The Influence of Stait's Despatch Post on the U.S. Postal System: 1849--1870

- **Purpose:** The exhibit's purpose is to examine the influence of Stait's Despatch Post on the U.S. Postal System and to illustrate handstamps throughout their postal history, including describing rates, routes, markings & contents.
- **Background:** In the 1830's & 1840's, many private carriers began across the United States. Each tried to compete w/ the U.S. Postal System for local mail in some fashion (e.g., cheaper, faster, more convenient). Local posts forced U.S. to reduce their short distance rates for ½ ounce from 10¢ in 1845 to 3¢ in 1855. Stait's was only 2¢ in 1850. William B. Stait was a former employee of American Letter Mail Company (1844-1845). He began Eagle City Despatch Post in summer of 1845, which ran as an intra-city post until about 1849. He also had an association w/ Adams' Express Company for intercity mail, noted on early Stait's handstamps. In late 1849 Eagle City became Stait's Despatch Post (likely due to U.S. using an eagle carrier stamp) & existed until 1859. According to Robson Lowe, Stait's Despatch was the only serious competitor to Blood's Despatch.
- **Plan:** To highlight types of Stait's Despatch Post handstamps (J, K, L, N & New). The exhibit is organized by type, as shown on the main headings. Types have used the lettering system since the early articles, such as Stimmell (1991), & are used in all known censuses. Types are presented in the following alphabetical order:

Difficulty of Acquisition: Every type ever catalogued is included in this exhibit, as well as one type recorded by Bowman in 2014 (1 of 1) & one type discovered and recorded by this exhibitor in 2022 (1 of 1). This exhibit includes first & last known Stait's Despatch Post covers as well as circulars. **Red** mattes are for difficult to acquire material; importance is noted nearby.

Stimmell lists cancellations as **red**. Lyons describes this type being used from June 8 1850 to Oct. 13 1851 (although this exhibit includes a Feb. 2 1850 cover) w/ 13 recorded examples.

Details of Type K: Stait's Despatch Post / AT / Adams' Exp'ss / PAID / & / 48 S. 3d st. Unique feature of this type is bolded **PAID** w/ Adams' Express noted (rate of 2ϕ & the US rate was 10ϕ). According to Lyons, this type was in use from late 1849 to April 10 1851, w/ over 25 recorded examples. Census lists this cancellation as **red** or **black**.



Details of Type L: Stait's Despatch / $48 / S_{0}^{o} 3^{rd} St / PAID$. Unique features of this type are enlarged **48** (referring to address) & no mention of Adams Express (rate of $2\notin \&$ US rate was $10\notin$). Lyons lists this type being used from March 1850 to May 1855, w/ over 35 recorded examples. Census lists as a **red** handstamp, but **black** occurs (as shown in this exhibit). May also be seen w/ **Type G**, the Eagle City Post Special Messenger depicted as / SPE^{CL} Mess^{GR} / FROM / Eagle Post / 80 Chestnut St. Lyons describes this type being used from Feb. 13 1849 to Dec. 15 1851 (although this exhibit includes a cover from June 4 1852) w/ 21 recorded examples. Census lists this handstamp as **red**.







Postmarks: **Black** double circle Stait's Handstamp (**black** not listed in census). Handstamped front & reverse (bottom reduced), cancelled at Englewood NJ with 3 cent US postage (Washington, first issued 1/3/1870).

Difficulty of Acquisition is High: Because of inclusion of US postage, this letter was mailed outside of Philadelphia. This occurred well after demise of Stait's Despatch Post, circa 1859. Thus Stait's handstamp must have occurred much earlier than circa 1870 posting & cancellation in New Jersey.

Contents: Standard envelope w/o contents.

Details of Type N: Stait's Despatch / Adams Express. / One Cent (in script typeface) / A pass. Unique feature of type is One Cent designation for rate (rate of $1 \notin \& US$ rate was $10 \notin$). Handstamp first recorded in Bowman (2014). According to Lyons this type was used circa 1850. Cancellation is **red. Not listed in any known census.**

5) Stait's Despatch Post: New Type & Epilogue

Details of New Type: Stait's Despatch / S. Third Street. / PAID. Unique feature of type (1857) is Third spelled out on handstamp. Similar in appearance to bogus cut adhesives of S. Allan Taylor, produced in later years only as cuts, but not on covers. Possible Taylor copied from this type (although font, spacing & apostrophe differ). Coster (1877) notes, but w/o illustration, "a simple handstamp reading Stait's Despatch, S. Third Street, Paid ... It is generally found struck in red" (p. 59). Coster is referring to this type as it is the only one w/ those characteristics. Not listed in any known census. Cancellation is red.





Epilogue: Following first US postage stamp of 1847, legislation began to increase US Postal System's monopoly over mail. By also making their rates competitive, by early 1860's most local posts were out of business.
