
ACKER'S SPECIAL DELIVERY

Finley Acker was the founder and president of the family owned Finley Acker Company, which operated several grocery stores in Philadelphia, Pennsylvania from 1882 to 1920. Acker's stores specialized in drinks (coffees, teas, and hot chocolates), candies, and cigars; but they also offered weekly special food items.

To advertise products, Acker created a detailed circular that was delivered weekly by request. These circulars were originally delivered by a private messenger, with an adhesive stamp. These stamps, reading "Special Delivery" were privately printed by Acker, and applied to the circulars until around 1898.

Sometime in the early 1900's, Acker was required to purchase a "Paid in Money" permit from the government, which it printed directly onto their circulars along with a modified "Ackers Local Delivery"

label image. Despite paying for the permit, the circulars continued to be delivered by private messengers until around 1906. Eventually, under pressure from the Post Office, the stamp-like label was removed from the circular altogether.
