# RPENTER & CO.'S EXPRESS

### COMPANY HISTORY

The Carpenter & Co.'s Kennebec Express service was founded by G.S. Carpenter in the early 1840s. The company specialized in carrying private mail and packages between cities from Massachusetts to Maine,

including Boston, Augusta, Hallowell, Gardiner, Richmond, and Bath. They also connected with Hale & Co. for forwarding to New York, and to cities outside of New England. In 1857, the company was absorbed by the Eastern Express Company.
