Descriptions in the Farrell Collection were written based on personal research and sources including, but not limited to: Articles in the Carriers and Locals Society's The Penny Post; Amos Media's Scott Catalogue; Patton's The Private Local Post of the United States; Springer's Handbook of North American Cinderella Stamps; Lyons' Identifier for Carriers, Locals, Fakes Forgeries and Bogus Posts of the United States; articles in the USPCS's The Chronicle; Mosher's Catalog of Private Express Labels and Stamps; The Eastern Independent Mail Companies and Express Mail Companies 1840-1845; Elliot Perry's Pat Paragraphs; James N. Drummond's Catalog of Philatelic Miscellany; and the notes of George Sloane and Gordon Stimmell.

Colors listed for stamps and forgeries are the opinions of the Farrell Collection based on viewing physical copies of the pieces under consistent lighting. Colors in the .pdfs may be slightly inaccurate due to manipulations from the scanning process, computer monitor settings, or (in event that the files are printed for offline viewing) the printing process.

Unless otherwise noted, stamps are identified by their Scott Catalogue numbers and forgeries are identified by their Lyons Identifier type. Scott numbers in parenthesis under listed forgeries represent approximately what stamp the forgery is attempting to imitate.

MEARIS' CITY DESPATCH POST

Established by Malcom W. Mearis in January 1846, this Baltimore local post carried letters within the city and to the post.

Mearis was a lawyer who was inspired by local posts in New York and Philadelphia. The post received mail at 100 letter box locations throughout the city, with his office located in the Jarvis Building. In the first three months of operation, the rates for delivery were 2¢ for letters carried locally, and 1¢ for letters to the mails. They also offered a special "fast horse" service to deliver letters directly to US mail agents for 2¢.

ADVERTISEMENT PUBLISHED IN THE *BALTIMORE CLIPPER* JANUARY 24, 1846

The stamps issued by Mearis were typeset, and printed in a form with multiple stamp types, based on the kind and arrangement of type elements. At least ten stamps were printed from a plate, evidenced by plate reconstructions with. Stamps were printed in two columns, with 2¢ stamps at left and 1¢ at right.

CITY DESPATCH POST.

THE UNDERSIGNED, desirous of being useful to his fellow citizens, begs to inform them that he has established a "City Despatch Post" similar to those in the other large commercial cities of the Union, by which persons, at the most distant points of the city, may communicate with each other without delay or trouble, and at a very small expense. It has been found emmently useful in New York, Philadelphia and floston, and is now sustained and ercouraged by all classes; and the undersigned, in offering himself to the public, pledges all that fidelity and industry can do to make it a convenient and useful establishment, and only asks, in return, the confidence and support of his friends and the public.

100 boxes will be posted at the different points of the city, specially enumerated by bills. The charge will be, upon a communication delivered to any part of the city, two cents, and lett rs to go out of town will be regularly mailed for one cent, which must be paid at the box. I will rec ive at the Golden Horse, car. Howard and Franklin sts. until quarter before 9; Mortimer & Mowbray's, cor. Charles and Baltimore streets, until 10 minutes before 9; and at Taylor, Whide & Co. and Sun office, until five minutes before 9 o'clock, A. M. All letters to go East, which will be carried by me to the mail agent at the lower depot by fast horse, for two cents each. Notices delivered tor associations and clubs at a small charge; also small packages delivered to any part of the city. Good collections attended to for a small per centage.

MEARIS' CITY DESPATCH POST

In April 1846, Mearis changed the rates to 3¢ for unpaid letters, and 2¢ for paid deliveries both within the city and to the mails. The cover shown here is dated April 28, 1846 and has no stamp affixed. The

ROM AND AFTER THIS DATE, uplou all communications unpaid, to be delivered
in the city, the charge will be 3 cents—but as usual,
Stamps to pre-pay can be had here and at the Head
Office, at 25 cents per dozen. Upon all letters to go
to the Post Office for Mail the charge will be 2 cents,
which must be paid at the Boxes or they will not be
mailed. Notices for Societies, Circulars and Catalogues, Invitations to Parties, Balls, &c. &c., served
at a low charge by the hundred, by calling at the office, Jarvis' Buildings, corner of North and Baltimore streets. Collections of all kinds attended to
with promptness.

In May, Mearis advertised the business for sale, and on May 20, Charles W. Reed purchased the post. Reed operated the local until October, when it passed to William Taylor and his agent R.K. Ford. The post became the Johnson & Co.'s City Despatch Post around November, 1847.
